What to bring: All participants should bring a bottle of water or should have access to drinking water.

Cancellations: Of any one part (i.e. one class or workshop): If Organisation cancels, terminates or reschedules for any cause less than seven (7) days from the next class date, Organisation shall pay Instructor 50% of total instructional service fees. If Organisation cancels, terminates or reschedules for any cause less than five (5) days from the next class date, Organisation shall pay Instructor 75% of total instructional service fees. If Organisation cancels, terminates or reschedules for any cause less than 24 hours from the next class date, Organisation shall pay Instructor 100% of total instructional service fees. In the event the Instructor cancels this agreement with less than 7 days notice, the Instructor will do all that is reasonable to secure a replacement Instructor. Neither the Instructor nor the Organisation shall be held responsible for cancellations due to State of Emergency Conditions, inclement weather related conditions, or other circumstances beyond the reasonable control of the parties. Of entire contract: If Organisation cancels, terminates or reschedules entire contract, 3 weeks' notice must be given in writing. Failure to do so means Organisation shall pay Instructor 100% of total instructional service fees. In the event the Instructor cancels this agreement with less than 7 days notice, the Instructor will do all that is reasonable to secure a replacement Instructor. Neither the Instructor nor the Organisation shall be held responsible for cancellations due to State of Emergency Conditions, inclement weather related conditions, or other circumstances beyond the reasonable control of the parties.

<u>Severability</u>: If any provision of this agreement shall be determined to be null and void or otherwise legally unenforceable, the remaining provisions of this agreement shall remain in full force and effect.
